Information requested on this application must be provided to obtain a retail food establishment license. Personal identifiable information you provide may be used for purposes other than that for which it was collected. Wis. Stat § 15.04 (1)(m). Licenses are not transferable between persons or locations. Licenses expire annually on June 30 th ; unless issued after April 1 st , which will expire on June 30 th of the following year. A late fee will apply to establishments that fail to meet license renewal deadline. The license fee is not prorated for partial license years. An operating without a license fee will be issued for all facilities that are operating without a current license.		
Within 30 days after receiving a complete application for a license, the department or its agent shall either approve the application and issue a license or deny the		
application. If the application for a license is denied, the department or its agent shall give the applicant reasons, in writing, for the denial.
